**O R D E R**

**03.01.2020** The brief facts of the Appeal(s) are as follows: -

**Company Appeal (AT) (Insolvency) No. 276 of 2019**

- The 'Resolution Plan' approved by order dated 12<sup>th</sup> June, 2019 is under challenge.
- Order dated 19<sup>th</sup> February, 2019 is also under challenge.
- Liquidation value of the Assets of the 'Corporate Debtor is Rs.69.91 crores (according to the Respondents); and fair value is

Rs.82 crores (according to the Respondents) excluding the mines of Karnataka.

- Mining lease has not been claimed in the 'Resolution Plan'.
- According to the Appellant(s), Liquidation value is Rs.253.98 crores including the mining lease.
- Total offer by 'Successful Resolution Applicant' is Rs.86 crores.
- Rs.5 crores is provided towards working capital.
- According to 'Plan' the distribution is: -
  - (i) Secured Financial Creditors - 100%.
  - (ii) Unsecured Financial Creditors – 25% of their claim (though liquidation value is zero).
  - (iii) Operational Creditors – 15% (even though the liquidation value is zero).
  - (iv) Aassaan Global Trade (Appellant – Unsecured Financial Creditor) has been provided 2.8% of admitted claimed amount.
  - (v) According to Aassaan Global Trade (Appellant – Unsecured Financial Creditor) the claim is not properly decided by 'Resolution Professional', against which an application under Section 60(5) was filed and rejected by order dated 12<sup>th</sup> June, 2019.

**Company Appeal (AT) (Insolvency) No. 716 of 2019**

- Aassaan Global Trade (Appellant - Financial Creditor) Appeal is only against other order dated 19<sup>th</sup> February, 2019, otherwise, same issues are raised as in the Company Appeal (AT) (Insolvency) No. 276 of 2019.

**Company Appeal (AT) (Insolvency) No. 557 of 2019**

- M. Mohamed Fahruddeen (Appellant – an employee) - Nobody appears.

**Company Appeal (AT) (Insolvency) No. 653 of 2019**

- Dr. Ravi Shankar Vedam (Appellant – Shareholder) – provided Nil amount.
- Initiation of ‘Corporate Insolvency Resolution Process’ was fraudulent (called by Section 65). The question will be, whether the Appellant – Dr. Ravi Shankar Vedam, Shareholder can raise issue of Section 65, once such issue was not raised when notice was given to ‘Corporate Debtor’ and also not raised the issue before the Appellate Tribunal thereafter?
- The Appellant is to answer as to whether Promoters intend to satisfy all the Creditors, if it is set-aside on the ground of Section 65?
- The Appellant, Shareholder has never filed any application under sub-section 5 of Section 60 raising any issue including issue relating to Section 65 before the Adjudicating Authority (National Company Law Tribunal).

**Company Appeal (AT) (Insolvency) No. 803 of 2019**

- Appellant in 2<sup>nd</sup> Appeal has also challenged order dated 9<sup>th</sup> July, 2019, rejecting the prayer for Forensic Audit.
- Corporate Insolvency Resolution Process (CIRP) started on 12<sup>th</sup> March, 2018 (date of admission).
- 270 days completed on 7<sup>th</sup> March, 2019 including period of exclusion.

- 'Resolution Plan' was approved on 27<sup>th</sup> February, 2019 by the Committee of Creditors.
- 'Resolution Plan' submitted by 'Resolution Professional' on 4<sup>th</sup> March, 2019, i.e. just prior to completion of 270 days after exclusion of the period and just before the final decision of the 'Committee of Creditors, which was rejected.

On the next date, the parties are to address on the issue strictly in terms of Section 61(3) of the I&B code and violation of any other provisions while rejecting one or other application under Section 60(5).

Post these Appeal(s) 'for admission (after notice)' on **22<sup>nd</sup> January, 2020** at 02:00 PM on the top of the list.

In the meantime, parties are allowed to file short written submissions not more than three pages on the issues as raised.
