UPON hearing the counsel the Court made the following

O R D E R

In terms of directions issued in these matters on previous dates, a tabular chart alongwith communication dated 18.9.2019 emanating from Asstt. Director of Income Tax (L&R) (SCC) has been placed for consideration of this Court. The letter and the tabular chart appended are taken on record and shall form part of the present order.

In these 70 matters as described in the chart, the tax effect is less than what has been prescribed in CBDT Circular No.17/2019 dated 8.8.2019. All the 70 SLPs therefore, stand dismissed for the reason that the tax effect involved in each of these matter is below the limit prescribed under the circular issued by the CBDT. Questions of law involved in these matters are kept open.

All the other matters shall be listed for final disposal on 5.11.2019.

In case there is any other matter where the tax effect is less than the limit prescribed in the circular of CBDT and if such matter is not a part of the tabulated chart, it shall be open to the concerned learned advocate to place such aspects on the next occasion.

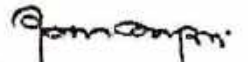
